IN RE: AIRPORT

To discuss part time employee Bud Widner going full time. Ron Powers ask where the revenue was coming from? Hangar rent. It's the business that sprays for Black Gold that makes a donation to the airport. Tracey Shorter made a comment that in the paper the Council said the Commissioners weren't making good decisions. We based the full time position for the Airport, based on the insurance information we received. Jim McDaniel said that at their last meeting, 3 board members would volunteer to work when Bud was off. He does not have to be full time he just has to be a county employee. Bud does do a daily inspection to the Airport.

Bud does not fuel the airplanes or move them. If we are having fueling done at the airport, there should be a form that says we only turn on the pumps. The rest is up to the pilot. So the County will be the owner of the fuel. Making Bud the manager, that way he would have liability to cover him; by being contracted he wasn't being covered by the liability. We need a form that the pilot's will pump the gas, and all we have to do is turn the pump on. We are not responsible for handling of the fuel.

The town of Winamac is contracted to still help pay 1/3 of the cost at the airport. We have appropriated money for the fuel and to reimburse Bud for his equipment.

There being no further business, the meeting was adjourned at 5:59 p.m., Eastern Savings Time. A motion to adjourn by Tracey Shorter. Seconded by Terry L. Young. Motion carried.
