IN RE: RENOVATION OF THE COURTHOUSE

Comes now, Jeff Johnston, Maintenance Director to give a report regarding the renovation of the Courthouse.

If you walk around our courthouse (the exterior) you will see some of the deteriorating that is going on. The sidewalks are cracked, some of the steps are cracked, which allows water to get in the courthouse.

The interior also has some deteriorating going on. The flooring doesn't match because they are worn and the tiles are broken or chipped. There are cracks through some of the courthouse walls. The wood on the staircase is coming apart. The wood flooring is gray where it is worn and wore down. We have trim that is torn or missing. The molding and trim on our decorative pieces that are cracked and missing. The ceiling is chipped and stained because of water leaks. Also the Circuit court walls have chipped and our falling down. The carpet is bunched up which makes it hazards to walk on.

Also discussed was to upgrade the telephone system, though out the Courthouse, Annex and Justice Center. Discussed was single point of entry for the courthouse, security issues.

Terry L. Young commented that Deb Girton & Tina Kasten left on May 1, 2015 from the County Home. Payroll, phone, inventory and keys had been given to Terry L. Young. Sale of the building and contents will be discussed.
