REGULAR SESSION

COUNTY COUNCIL

The Pulaski County Council met in regular session on September 14, 2015 in the Commissioners Room at the Courthouse in Winamac, Indiana, at 7:00 p.m. Eastern Standard Time. Meeting was called to order by Jerry Sullivan, President, also present were: Roger Querry, Vice-President, Thomas J. Roth, Alexsondra Haschel, Linda Powers, Douglas Roth and Shelia K. Garling, Auditor. Michael T. Tiede was absent.

Also present was: Tyler Maffitt, Amber Tomlinson, Jason Bunger, Michelle Grostefon, Cathy Elston, JoLynn Behny, Jeff Johnston, Gary Kruger, Terry Ruff, Carrie Aaron, Fred Rogers, Wade Wake.

IN RE: MINUTES APPROVED

The County Council approved the Council minutes for the September 14, 2015 meeting as submitted upon a motion made by Linda Powers. Seconded by Douglas Roth. Motion carried.

IN RE: PUBLIC HEARING ON THE BUDGETS

The Public Hearings for the 2015 budgets were open per Jerry G. Sullivan. Discussion was done at lengthy trying to find how to make the total cuts that need to be done. Jerry Sullivan, said to take the liability insurance out of the Rainy Day Fund and cut it from the County General Fund. Airport budget, they cut most of the appropriation. It was suggested to look into The Airport Authority, which separates the airport from the County Funds.

IN RE: NON BINDINGS

Motion made by Roger Querry, to approve the non-bindings as presented. Seconded by Douglas Roth. Motion carried.

IN RE: LOCAL OPTION INCOME TAX

The LOIT (Local Option Income Tax) is in the form of a public safety county adjusted gross income tax to adequately fund the expenses associated with public safety. To adopt this resolution we need to advertise and set up a public hearing. The amount that we have set .0025 is the max amount we can ask for. The money we receive will be divided up with the County, and the Town taxing units. Motion made by Doug Roth to approve, seconded by Thomas J. Roth. Motion carried.

IN RE: REGARDING INCREASE OF WAGES

Michelle Grostefon made a comment regarding increase in the wages that the FICA/SOC SEC, PERF, Overtime will cost more because of wage increases. Linda Powers, Jerry Sullivan and Douglas Roth also made comments regarding these increase of wages. Cathy Elston made comments regarding the increase in wages. Sheriff Richwine was describing what the Matrix project was and that he had it done for the Sheriff's department. Roger Querry commented regarding the Matrix that we had heard years ago about new employees making the same thing as the person that has worked here for years.

IN RE: RESOLUTION FOR AN ECONOMIC REVITALIZATION AREA

Comes now, Nathan Origer to request the approval of a preliminary resolution for an economic revitalization area (ERA) regarding property in the industrial park owned by R & S Welding. Nathan said the ERA status make the property eligible for a tax abatement, but there is no request for a tax abatement, it just makes it eligible. Motion made by Douglas Roth to adoption this preliminary resolution and tell me to come back at the next meeting next month for public hearing. Seconded by Thomas J. Roth. Motion carried.

Nathan brought up the LOIT tax. Suggested that the county take a hard look at the county taxes. He said the income tax may not be the best answer but possible shifting some of the burden of the income and onto property. He said land and buildings don't move but people do. If you raise the taxes even more on income you are only going to encourage more people to leave the county thus lowering your tax base. Nathan gave some examples for why he feels that way he does about increasing our income tax. There is no easy answer for this.

Jerry Sullivan didn't completely agree with what Nathan said. Nathan comments were appreciated.

IN RE: RESOLUTION TO AUTHORIZE CREDIT CARDS AT RECYLING/TRANSFER STATION

Comes now, Brad Bonnell, Manager to implement a resolution authorizing the acceptance of credit cards and establishing procedures for credit card acceptance for collecting payments. He said there is quite about of interest in being able to use this machine, even though they know that there is an additional fee to the consumer. Motion made by Douglas Roth to approve, seconded by Linda Powers. Motion carried. Mr. Bonnell also made comment on the matrix, he is requesting that they take into consideration the special certifications that some of the employees at the recycling/transfer center ha e, such as CDL. He would like to be able to offer skilled employees a higher wage. Linda Powers commented that it would be taken into consideration.
