### Discussed alternatives to project

- New Construction of 22,000 sq ft \$200 \$350.00 per sq ft
  - Translates to \$4.4mil to \$7.7mil
- Alternate existing buildings, New construction on current site, and new construction on other sites not feasible due to distance or cost
- o Demolition of current courthouse not feasible due to cost and process
- o Every architect firm contacted stated it is cheaper to repair and add on than it is to build new.

#### Phil Savich from Arsee Engineers

- Presented repairs needed to structure and roofline
- Presented repairs required in attic

#### **Rob Galbraith from Keystone Architecture Inc.**

- Discussed ADA requirements for public buildings
- Discussed Single point of entry and security mandates
- Presented architectural drawings for new addition and courtyard
  - o Explained how new addition would bring us into compliance

#### **Todd Samuelson from Umbaugh and Associates**

- Discussed bonding process, how it works
- Presented figures for construction process and added cost for financing
- Discussed how project would be paid for through property taxes
  - o Presented rates and individual responsibility
