

**PULASKI COUNTY DRAINAGE BOARD**

**OCTOBER 17, 2016**

The Pulaski County Drainage Board met on October 17, 2016. The meeting was called to order by President Bud Krohn Jr. at 2:30 p.m. in the Commissioner's Room, third floor of the Pulaski County Courthouse.

Present was President Bud Krohn Jr., Terry Young, Larry Brady, Attorney Tim Murray, Jenny Keller and Susan Thomas.

**MINUTES**

Larry: I make a motion that we approve the minutes from the last meeting.

Terry: I'll second.

Bud: All in favor say aye. Motion carried.

**HANSELL DITCH**

Jenny: Doug Clapp called in and reported that the ditch was washing out next to his drive. I have DeSabatines fixing that. The estimate is \$2,200.00

**ANTRIM**

Jenny: Dan reported a slide in on 340 N across from Herbert Wrights. I contacted Jerry Gutwein and he will take care of this. His estimate is \$300.00-\$350.00 to fix.

**SLICK DITCH**

Jenny: Rudy DeSabatine called in asking about the status of cleaning of the Slick Ditch. I told him that it is on our list to survey.

**PIFER**

Jenny: Bill Kolish called in. He has standing water in his field. The water is like even with his ground. It doesn't do any good to go in and clean his stretch so we're going to have to go in and survey the whole thing and clean the whole ditch.

**WUETHRICH/LOWRY**

Jenny: Jerry Gutwein on the Wuethrich ordeal wanted to know if it was a go. I told him yes. Jerry said that he would contact Richard before he started.

Larry: We've already ruled on it and if Jerry wants to go and converse with Richard Lowry then that's up to Jerry.

**NIPSCO-REYNOLDS TOPEKA**

Jenny: I talked to Chris Heaton today from NIPSCO. They're doing that TOPEKA project. He has three sites, number 53, 55 and 57. Number 53 is a dean end. There is just so much water that he wants to know if they can use the dewatering system. They're only getting down three foot and they're hitting water. What he wants to do is designate a spot to put all the water. He would like to designate roadside ditches or ditches. If we say yes, then he will call the landowners and talk to them.

Larry: My opinion is to approve anything moving forward but they would need to assure that the landowner knows about it.

Terry: Go for it.

Bud: Tell him to use his best judgement and talk to the people and just go for it.

**ROAD ABATEMENT – CR 1050W**

Larry: So on the abating of the County Road 1050W between 900S and 1000S for Kevin Tankersley, the Drainage Board would do the petition for that road to be closed and present it to the Commissioners.

Terry: I would make a motion to petition the Commissioners to do said road abatement.

Larry: I'll second that motion.

Bud: Motion carried

**FRAIN TILE**

Larry: Any updates on the Frain Tile?

Jenny: No. I've been working non-stop on Indian Creek.

**INDIAN CREEK**

Bud: We're supposed to have a hearing around the middle of December.

Jenny: I will get back on the Ed Frain Tile.

**TOWN OF FRANCESVILLE**

Larry: In regards to Francesville with the drainage issues, I believe we as a County have done what we can. Their issue is coming up with funding. I don't know what else to do. It's definitely their issue.

**BONNELL DITCH**

Bud: Have you heard any more on the Bonnell Ditch?

Jenny: I need to talk to Tim Weaver. There's not money built up in the fund yet. I'll get with Tim and see if Weaver/Fox will do it.

**HARPSTER TILE**

Larry: Any update on Bob Meyer and the Harpster Tile?

Jenny: We are going to clean the Harpster but no I haven't heard from Bob as to the tile portion of it.

**CLAIMS**

Larry: I will move to approve the claims as presented.

Terry: I'll second.

Bud: All in favor. Motion carried
