REGULAR SESSION

COUNTY COUNCIL

The Pulaski County Council met in regular session on August 14, 2017 in the Commissioners Room at the Courthouse in Winamac, Indiana, at 7:00pm Eastern Standard Time. Those present were Jerry Sullivan Mike Tiede, Thomas J. Roth, Alexsondra Haschel, Kenneth Boswell, Scott Hinkle, and Auditor Laura Wheeler. Linda Powers was absent.

IN RE: JUSTICE CENTER

Sheriff Richwine presented a security system quote for \$160,500.00 from Security Automation Systems. The current electronic door control, card access, and intercom systems are obsolete. It will take six months to install. The consensus is to pay for the system outright rather than taking on a lease. The decision was tabled for further review

The Sheriff requested more pay for a part-time dispatcher. She currently has worked for 17 months but worked here previously for 8 ½ years. The request was taken into consideration.

IN RE: HUMAN SERVICES

The Council considered Human Services' advertised request for an additional \$6,894.00 to pay the remaining balance for a vehicle. Kenneth Boswell motioned to table approval of the additional request, and Thomas J. Roth seconded the motion. Motion carried unanimously.
