REGULAR SESSION June 05, 2017

PULASKI COUNTY BOARD OF COMMISSIONERS

The Pulaski County Board of Commissioners met at 6:00pm Eastern Time on June 05, 2017 in the Commissioners' Hearing room, at the Courthouse in Winamac, Indiana. Present for the meeting were Commissioners Kenny Becker, Jerry Locke, Attorney Kevin Tankersley, and Auditor Laura Wheeler. Commissioner Bud Krohn, Jr. was absent.

Also, present, were Amber Tomlinson, Jeff Johnston, Judge Michael Shurn, Dwain Davis, Carroll Lange, Nathan Origer, Jeff Richwine, Ray Franko, Justin Perry, Michael Veenhuizen, Jared Brown, Phil Brown, Tom Fritz, John and Sara Green, Dave Bennett, Miguel Salazar, Bob Zavacky, Joe Moyer, and Gene Timm.

Commissioner Kenny Becker opened the meeting with the Pledge of Allegiance.

IN RE: MAINTENANCE

Jeff Johnston presented an addendum to the agreement from November 23, 2015 to reflect a change in the project to complete an ADA elevator installation. The contract amount for Architectural, Structural, and Electrical Engineering will be a lump sum of \$32,000.00. Kenny Becker motioned to accept the addendum as presented and Jerry Locke seconded the motion. Motion carried.

Jeff Johnston also reported on justice center repairs and other repairs within the county governmental offices.

ApexBenefits, R&R Benefits/Risk Management, and Consolidated Union insurance companies have yet to submit quotes. The Commissioners tabled the decision for further review of the information.

IN RE: ZONING

The Pulaski County Advisory Plan Commission presented an application to rezone property located at 700 W & 300 S, Winamac, IN 46996 from an A-1 General Agriculture District to an A-2 Intensive Agriculture District to allow the construction of a confined feeding operation. The purpose is to produce a wean-to-finish pig operation.

Tom Fritz and John & Sara Green approached the Commissioners in protest of the considered re-zoning request because of the potential decrease in the value of their respective residences.

The Commissioners will table the issue until a later date.

IN RE: COUNTY HOME SALE

Dwain Davis reported that Tristan Clark was the high bidder for the County Home Property auctioned on Saturday, June 3, 2017. Jerry Locke motioned to accept the bid from Tristan Clark of \$26,000.00 for the County Home property and Kenny Becker seconded the motion. Motion carried.

The Commissioners received a request from Jim Greeson, Indiana State Fire Marshal for an agreement between Pulaski County and IU Public Policy Institute for GIS Information. Kenny Becker motioned accept and sign the agreement from IU Public Policy Institute and Jerry Locke seconded the motion. Motion carried.

Sheriff Richwine is in the process for housing federal prisoners and now needs part time people to help transport. He will collaborate with the Auditors Office for the funding of this project.
