REGULAR SESSION

COUNTY COUNCIL

The Pulaski County Council met in regular session on July 10, 2017 in the Commissioners Room at the Courthouse in Winamac, Indiana, at 7:00pm Eastern Standard Time. Those present were Mike Tiede, Thomas J. Roth, Alexsondra Haschel, Linda Powers, Kenneth Boswell, Scott Hinkle, and Auditor Laura Wheeler. Jerry Sullivan was absent.
