The Pulaski County Board of Commissioners met at 6:00pm Eastern Time on October 02, 2017 in the Commissioners' Hearing room, at the Courthouse in Winamac, Indiana. Present for the meeting were Commissioners Kenny Becker, Jerry Locke, Mike McClure, Auditor Laura Wheeler, and Attorney Kevin Tankersley.

Commissioner Kenny Becker opened the meeting with the Pledge of Allegiance.
