REGULAR SESSION

COUNTY COUNCIL

The Pulaski County Council met in special session on February 12, 2018 in the Commissioners' Room at the Courthouse in Winamac, Indiana, at 7:31pm EDST. Those present were Jerry (Jay) Sullivan, Mike Tiede, Thomas J. Roth, Kenneth Boswell, Scott Hinkle, Linda Powers, Alexsondra Haschel, and Auditor Laura Wheeler.

Also present were: Amber Tomlinson, Jerry Locke, Michael Gallenberger of WKVI, Jeff Richwine, Nathan Origer, Bryan Corn, and Brian Young.

IN RE: CDC

Nathan Origer asked to discuss one percent increase for County employees. After some debate, the Council determined that regardless of the exceptions all full-time County employees should have received the increase. Kenneth Boswell motioned to amend the salary ordinance as needed to give everyone the 1% raise and Thomas J. Roth seconded the motion. Linda Powers and Alexsondra Haschel both abstained from the vote. The remaining five were all in favor of the motion. Motion carried.
