The Pulaski County Board of Commissioners and the Pulaski County Council met at 6:00pm EDST on April 9, 2018 at the Pulaski County Highway Garage in the Conference room, Winamac, Indiana. Present for the meeting were Commissioners Kenny Becker, Jerry Locke, and Mike McClure. Council members present were Jerry (Jay) Sullivan, Thomas J. Roth, Kenny Becker, Scott Hinkle, and Auditor Laura Wheeler. Michael T. Tiede and Alexsondra Haschel arrived during the meeting. Linda Powers was absent.

IN RE: SPEED LIMIT ORDINANCE

Don Scheffer and Rebecca Stalbaum requested the reduced speed limit on 1550 W between 150 North and 300 North be permanent. Kenny Becker motioned to adopt the speed limit ordinance as stated below and Jerry Locke seconded the motion. Motion carried unanimously. Council member Thomas J. Roth motioned to adopt the speed limit ordinance as stated below and Scott Hinkle seconded the motion. Motion carried unanimously.

JOINT ORDINANCE ON SPEED LIMIT ON COUNTY ROAD

WHEREAS, The Board of Commissioners of Pulaski County and the Pulaski County Council have the power to regulate traffic on any highway in the county highway system under the authority of *I.C.* 8-17-1-40, *I.C.* 9-21 and pursuant to the Joint Ordinance enacted on August 22, 1994; and

WHEREAS, The Board of Commissioners and Pulaski County Council have determined that the speed limit on County Road 150 North lying West of U.S. 421 to 1550 West shall be 30 mph; and

WHEREAS, The Board of Commissioners and Pulaski County Council have determined that the speed limit on County Road 1550 West lying between 150 North to 300 North shall be 30 mph; and

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of Pulaski County and the Pulaski County Council that after the erection of an appropriate speed limit sign that conforms to the state manual and specifications showing 30 miles per hour limit that the speed limit on County Road 150 North lying West of U.S. 421 to 1550 West; and County Road 1550 West lying between 150 North to 300 North; and County Road 300 North lying between 1550 West and U.S. 421 shall be 30 mph.

Violation: Any person who violates any portion of this ordinance shall be guilty of a Class "C" infraction and may be fined accordingly.

Effective Date: This ordinance shall be in full force and effect on passing by the Pulaski County Board of Commissioners and Pulaski County Council, and the posting of proper signs, giving notice of the traffic regulation, and the required publication has been completed in the accordance with Indiana law.
