COUNTY COUNCIL

The Pulaski County Council met in regular session on September 10, 2018 at the County Highway Garage Training Room in Winamac, Indiana, at 7:00pm EDST. Those present were, President Jerry (Jay) Sullivan, Thomas J Roth, Scott Hinkle, Kenneth Boswell, Linda Powers, Michael T. Tiede, and Auditor Laura Wheeler. Alexsondra Haschel absent.

Also, present, were Amber Tomlinson, Michael Gallenberger of WKVI, Kenny Becker, Jerry Locke, Holly VanDerAa, Joe Moyer, Maurice Loehmer, Jerry Keller, Jim Potthoff, Sharon Weldon, Harry Mohler, Sean McGill, Ryan Fetters, Renita Potthoff, Justin Schramm, Marge Manikowski, Mary Penksa, Colleen Klausing, Doug Klausing, Marian Reinhold, Cheryl Hunneshagen, Steven Reinhold, Sharron Reinhold, Doris Smith, Daniel Smith, Christine Sellers, Melvin Brown, Kathy Miller, Mike McClure, Linda McCune, Beverly Smith, Stan Brown with One America, Jeff Richwine, and Jason Woodruff.

President Jerry (Jay) Sullivan opened with the Pledge of Allegiance.

IN RE: MONTEREY LIBRARY

Justin Schramm and Renita Potthoff fielded questions regarding the scope of the project of the renovation of the Monterey Library.

Ryan Fetters and Shawn McGill from Umbaugh helped explain the cost estimates.

The Monterey Library board is asking approval for a \$370,000.00 bond to make renovations and repairs. This amount will retain the \$30,000.00 per year payment that has been made for the past 20 years on the now maturing bond. The Architect has provided a list of the needs. The estimated impact to a property owner is 2.48 cents and the county is not liable for the loan.

Jerome Keller asked if \$30,000.00 worth of renovations could be done each year thereby saving approximately \$188,000.00 in interest and estimating that the list could be completed in 5 ½ years. However, technically speaking, there is not \$30,000.00 per year without the Bond and the renovations and repairs are an immediate need.

After a great deal of more discussion and questions concerning the cost of the items on the list, Kenneth Boswell motioned to approve the Resolution of the Pulaski County Council approving the Monterey-Tippecanoe Township Public Issuance of Bonds as presented but if the bids come in under the estimated cost then the excess should be returned to the taxpayer. Thomas J Roth seconded the motion. Motion carried unanimously.

IN RE: JUSTICE CENTER

Sheriff Richwine and Stan Brown of One American explained the sheriff's 20-year pension plan. The Sheriff used commissary funds to hire Stan to review the current plan and make recommendations. Richwine wants to look at the retirement fund as an incentive for deputies to stay in Pulaski County and encourages the Council to consider a 32-year or 36-year plan.

Stan works with 91 of the 92 counties in the state. There are only 14 Counties in the state who still have a 20-year retirement plan. A 26-year retirement plan for 2019 will increase the cost by \$18,000.00 annually. Currently the County pays 17% into the plan but the employee is required to pay their own 3% into the plan. An employee is 100% vested after 7 years. Kenneth Boswell wants time to review the information and requested that Stan Brown return to October or November meeting.

Sheriff asked for approval on using commissary funds to hire Natalie Fedderer to write a Grant for the work release program. A 1006 Grant funds employees, schooling, and training.

Michael T. Tiede motioned to approve the use of commissary money to pay Natalie Federer to write a Grant for the sheriff for the work release program. Scott Hinkle seconded the motion. Motion carried unanimously.

Richwine explained the need for a new 9-1-1 phone system, which will include corporals' radios, camera system, and better storage options. The system has 12 cameras and 20 portables. The cost is approximately \$80,000.00 for the system and Kevin Tankersley is reviewing the contract.

IN RE: ASSESSOR

Holly VanDerAa explained the need for the Reassessment levy to increase from \$116,000.00 to \$160,000.00. This will cause the current rate of .0132 to increase to approximately .0175. The costs of reassessment are going up due to the changes in legislature. Council will consider the request prior to adopting the 2019 budget on October 8, 2018.
