REGULAR SESSION

PULASKI COUNTY COMMISSIONERS

The Pulaski County Commissioners met in regular session Monday August 15th 2022 8:30am ET at the Pulaski County Highway Department training room. Commissioners present were Charles Mellon, Maurice Loehmer, Michael McClure with County Auditor Laura Wheeler and County Attorney Kevin Tankersley.

Also present were Sherri Gaillard, Patrick Daly, Megan Galbreath, Jeff Richwine, and Chris Schramm.

President Mellon opened the meeting with the Pledge of Allegiance.

IN RE: EMS

American Disability Act (ADA) Transition Plan presented for review and approval. Indiana Department of Transportation (INDOT) informed the County that their ADA Transition Plan and Title 6 was in noncompliance. Maurice Loehmer made a motion to adopt the ADA Transition Plan as presented, Michael McClure seconded and motion carried unanimously.

The annual Hazardous Material Full Scale Exercise drill is scheduled for September 17, 2022 at US#35 and CR 225 S starting at 9:00am. Sign up is at the Sheriff's office.

Indiana Homeland Security is conducting the district exercise on September 23, 2022 with training in damage assessment out of the Sheriff's office.

Patrick Daly asked Commissioners approval to conduct a "burn-out" contest in front of the fire station during Monterey Days Festival on September 4. 1st Choice Insurance in North Judson is expected to cover the event. The Monterey Town Board said it would need to be conducted outside City limits. Michael McClure made a motion to approve the event pending all legalities and insurance are in place and there is no risk to the County. Spectators will be behind cement barriers and signed Hold harmless agreements in place. Maurice Loehmer seconded the motion. There is no expected damage to the road. Motion carried unanimously.
