The Pulaski County Commissioners met in regular session Monday November 7, 2022 at 6:00pm at the Pulaski County Highway Department training room. Commissioners present were Charles Mellon, Maurice Loehmer, Michael McClure with Pulaski County 1st Deputy Auditor Mary Mays and County Attorney Kevin Tankersley.

President Mellon opened the meeting with the Pledge of Allegiance.

IN RE: CASA

The 2023 State CASA/GAL Grant application presented for approval. This is for Court Appointed Special Advocates (CASA) with \$12,490.00 being the State allowed maximum. Maurice Loehmer made a motion to approve the application as presented and Mike McClure seconded. Motion passed unanimously.

IN RE: PANDHANDLE PATHWAY

John Bawcum & Fred Kasten gave an update on the Panhandle Pathway expansion project. A 2.5 million dollar grant award makes the expansion possible. The Project will start in Winamac on SR#14 west and extend north up to the back of McDonalds and the south end extending to the France Park entrance will begin in 2024. The Grant Money must be spent by December 2025. Future plans are to run path up to State Park. The State Park is working with the Town of Winamac to run sewer and water lines to park and hopefully the pathway can piggy-back on this project. There is a 20% match required, which the PanHandle Pathway LLC has.

IN RE: LOCAL EMERGENCY PLANNING COMMITTEE (LEPC)

Order of Promulgation, updated as of October 21, 2022, presented for review and approval. The recent EMA vacancy discussed briefly. LEPC will interview potential candidates and bring recommendation to the Commissioners. The commissioners stated intent to advertise as a part-time position but expected this to be discussed at the December joint session and appoint position at the January 3, 2023 regular meeting.

IN RE: JUSTICE CENTER

A \$44,088.44 estimate from Small's Maintenance and Electrical LLC for a battery-backup in the Justice Center serving the County servers presented for consideration. The Jail, dispatch, and 911 already have one but it is not big enough for the entire building. Tabled for further review.

IN RE: CDC

An issue with an HVAC noise in the CASA office and doors/hardware have justice center completion delayed.

There is a site visit for interested contactors for the County Highway Roof repair/replacement at 11:00am on November 21, 2022 with quotes due to CDC by 4:00pm on December 9, 2022 and expected to be opened by the Commissioners at the December 12, 2022 joint session.

A Legal notice for bid solicitation has been published for the Justice Center Work release facility. There is a pre-bid meeting at 2:00pm on November 21, 2022 with bids due to the CDC office by 4:00pm on December 9, 2022 and will be opened by Commissioners at the December 12, 2022 joint session.

The courthouse renovation project <u>start date is moved to</u> June or July 2023. Architectural drawings are in second round; steering committee meetings and one on one department meetings expected. Cost savings discussed briefly. The east annex building will be used as temporary offices for the Assessor, Auditor, Recorder and Treasurer during the renovation. The 117 E Main Street building next to Pulaski County Abstract will be the temporary location for the Clerk's office at \$600.00 per month plus utilities. Maurice Loehmer made a motion to approve the Clerk's temporary location, Charles Mellon seconded and motion carried unanimously. County Attorney will draw up a lease.

Authorization requested to move forward with the first formal step to establish a Pulaski County Redevelopment Commission, which has to be ordained by the Board of Commissioners, and a Pulaski County Economic Development Commission, which ultimately has to be ordained by Council. Decision tabled for the December 12, 2022 joint session.

IN RE: OTHER BUSINESS

Maurice Loehmer made a motion to approve claims and payroll #22, Michael McClure seconded and motion carried unanimously.

Maurice Loehmer made a motion to approve the October 14, 2022 regular session minutes and the November 03, 2022 special session minutes as presented, Michael McClure seconded and motion carried unanimously.

Charles Mellon made a motion to appoint Taylor White to the Pulaski Memorial Hospital Board of Trustees as recommended, Maurice Loehmer seconded and motion carried unanimously.
