SEPTEMBER 12, 2022 REGULAR SESSION

PULASKI COUNTY COUNCIL

The Pulaski County Council met in regular session Monday September 12, 2022 7:00pm at the Pulaski County Highway Department training room. Councilmembers present were Ken Boswell, Ron DeSabatine, Mike Tiede, Kathleen Thompson, Tim Overmyer, and Jerry Locke with County Auditor Laura Wheeler. Adam Loehmer absent

President Boswell opened the meeting with the Pledge of Allegiance.

IN RE: WINAMAC POLICE DEPT

The Town of Winamac and has been working with Eastern Pulaski Community School Corporation (EPCSC) to put a full-time officer in the school with the cost split evenly between Town and School. Would the County contribute financially to this endeavor since many students live out of the City limits? Total cost is expected to be \$70,000.00, including benefits and would be a Town employee. After some discussion, Council is taking request under advisement.

IN RE: COUNTY PROPERTY SALE

Sale of the Old County Home property, approximately 1.2673, discussed. Part of the property was sectioned out for use by REACT. Council previously recommended an auction sale but Commissioners prefer listing with local agent and include an escalation clause. Kathleen Thompson made a motion to change selling method from auction to realtor listing, Jerrry Locke seconded and motion carried unanimously.

IN RE: CDC

New furniture costing \$61,783.73 installed in Circuit Court and Prosecutor's offices.

Retrofit vs. full-system replacement on the County Highway roof discussed. A full system replacement as an alternate bid considered but will proceed with a flute-fill retrofit, which should save the County money. In a flute-fill retrofit, valleys between ridges on each sheet of metal roofing are filled with insulation, a layer of sheathing applied over this now flat surface and then a rubber roof membrane installed.

Tonn & Blank has submitted their first draft cost estimate based on Luminaut/Rowland's drawings which will be discussed at October's Joint Session.

Document Retention continues to be a renovation challenge. Scanning and storage need evaluation and retention plan.

Temporary renovation locations discussed briefly.

It is not prudent to include the west annex rehabilitation in the courthouse project. The Architects suspect it would be a better fiscal decision to build a new structure and raze the existing building.

The Local Income Tax (LIT) reallocation discussed. After some discussion, Kathleen Thompson made a motion to approve Option 2, Mike Tiede seconded and motion carried unanimously. **Option 2**: PSAP down from 0.30% to 0.225% and Economic Development up from 0.50% to 0.575%.

The County's Rainy Day Fund is not Code-Compliant and should have been established as an ordinance, not a resolution, which was done in 2015. A proper ordinance explicitly addresses the allowed uses of the Rainy Day Fund. Council will discuss and outline eligible spending uses for this fund and adopt a corrective ordinance in the very near future.

A wage-and-benefit study in-house rather than hiring a consultant requested by Mike Tiede and Ken Boswell. Comparable data is from 18 counties focusing on department heads/supervisory positions, posted budgets, and staffing.

Council meeting recessed for a Public Budget hearing.

Budget changes include CDCs marketing budget reduced to \$55,000.00 and security reduced to \$10,000.00.

The overall 2023 budget for a total expected adoption amount of \$22 Million discussed. 2023 budget has \$2.4 million in ARPA money, a 5% pay increase, Courthouse and Justice Center bond payments, and an increase number of grants. Revenue estimated increase is 7-8%.

Kathleen Thompson made a motion to approve and sign August 8, 2022 regular session minutes as presented, Ron DeSabatine seconded and motion carried unanimously.

The budget hearing minutes presented for approval. Mike Tiede made a motion to approve and sign budget hearing minutes with a correction to EMA noting that the increase for drones was a carryover from the 2022 budget minutes and should be deleted. Kathleen Thompson seconded and motion carried unanimously.

Adoption of the 2023 budget will be at the October 10, 2022 Council meeting at 7pm.

The Town of Winamac board no longer contributes to the County's 9-1-1 cost. After some discussion it was determined that Kenneth Boswell and Jeff Richwine would address the Winamac Town Council.

Police officer assigned to Eastern Pulaski School Corporation discussed further. Schools receive funding for safety and should provide their own safety officer was the consensus.

With no other business to discuss, the meeting adjourned at 8:51pm.
