# PULASKI COUNTY COMMISSIONERS

The Pulaski County Commissioners met in regular session Monday March 6, 2023 6:00PM at the Pulaski County Highway Department training room. Commissioners present were Charles Mellon and Maurice Loehmer with County Auditor Laura Wheeler and County Attorney Kevin Tankersley. Commissioner Michael McClure was absent.

Also present were Judge Crystal Kocher, Dr. Carrie Cadwell, Nathan Origer, Leeann Wright, Jennifer Knebel, Connie Ehrlich, Megan Galbreath and Chris Schramm.

President Mellon opened the meeting with the Pledge of Allegiance.

### IN RE: SUPERIOR COURT

Updates presented on Pretrial Release and Community Navigator grants as well as a letter of support needed for another grant application. Commissioners approved and signed the letter of support.

### IN RE: 4C HEALTH SERVICES

Dr. Carrie Cadwell, CEO of 4C Health services (formerly Four County) gave a review of 2022 Pulaski County services. In 2022, 20,290 services provided for 495 residents, twice the number of services as those given in 2018. Of the 495 residents serviced, 40% were age 0-18; 304 were admissions from Pulaski County with 52% being new. The 4C budget for Pulaski County in 2022 was \$2,000,000.00 with \$18,000.00 in Pulaski County payroll taxes. Other programs also discussed.

### IN RE: CDC

Superior Court carpet has been ordered and should be installed the end of March. Panic alarms at Justice Center being reviewed. Winamac Coil Spring Ioan from 9 years ago is still in compliance. Courthouse scanner options discussed briefly.
