The Pulaski County Commissioners met in regular session Tuesday June 20, 2023 (due to June $19^{\text {th }}$ Holiday) 8:30am at the Pulaski County Highway Department training room. ## IN RE: JASPER-PULASKI FISH \& WILDLIFE AREA

Tom Despot of the Indiana Division of Fish \& Wildlife requested the Commissioners sign a letter of support for a new office/visitor center at the Jasper-Pulaski Fish \& Wildlife Area. Funding will be requested from the State budget agency by Thursday, June 22, 2023. Additional tourism is expected, especially when sand hill cranes are present and the current facilities are very old. Maurice Loehmer made a motion to sign the letter of support as presented, Michael McClure seconded and motion carried unanimously.

## IN RE: EMS

The ambulance bids discussed briefly with a recommendation to accept Crossroad Ambulance Sales \& Service, LLC, for the bid amount of $\$ 258,967.00$. Although Fire Service's bid was a little less, modifications were made after the bids were opened whereas, Crossroad's bid matched the specifications exactly. Maurice Loehmer made a motion to accept the Crossroad Ambulance Sales \& Service, LLC bid as presented, Michael Loehmer seconded and motion carried unanimously. A trade-in may be a later option.

EMS employees complain of fatigue and low morale and suggest a 48/96 shift rather than the current 24/48 to combat this. Michael McClure made a motion to move forward with an optional 48/96 shift, Maurice Loehmer seconded and motion carried unanimously.

    WHEREAS Bottlebrush Energy LLC ('Bottlebrush') is contemplating the development of a solar-energy generation facility ('Project'), which will consist of approximately 200-250 megawatts in nameplate capacity

    WHEREAS Bottlebrush has requested assistance with the completion of certain road improvements, assistance with land use and other permits, the approval of assessed-value deductions, and other aid from the County with $1 \cdot$ espect to the Project;

    WHEREAS, to induce Bottlebrush to complete the Project, the Board desires to approve the execution of an Agreement for Economic Development ('Agreement') between the County and Bottlebrush, a form of which has been executed by the Pulaski County Council ('Council') and presented to the Board on the date hereof, pul'Suant to which certain incentives will be provided to Bottlebrush in exchange for its commitment to complete the Project, to make certain economic-development payments, and to take certain other actions with respect to the Project,

    NOW, THEREFORE, BE IT RESOLVED by the Board that:

    1. the execution and delivery of the Agreement are in the best interests of the County and its citizens;
    2. the Board is authorized to execute the Agreement in the name and on behalf of the County, and the County Allditor is hereby authorized to attest such execution of the Agreement with such changes and modifications as such persons deem necessary or appropriate to effectuate this Resolution, said persons' execution thereof to be conclusive evidence of the approval of such changes; •
    the Board, the members of the Council, the County Auditor, the legal counsel of the County, and other appropriate officers of the County are hereby authorized to take all such actions and to execute all such instruments as are necessary or desirable to effectuate this Resolution; and
    3. this Resolution shall be in fullforce and effect from and after its adoption.
