The Pulaski County Commissioners met in regular session Monday December 4, 2023 at the Pulaski County Highway Garage training room. Commissioners present were Charles Mellon, Maurice Loehmer, Michael McClure with County Auditor Laura Wheeler and County Attorney Kevin Tankersley.

President Mellon opened the meeting with the Pledge of Allegiance.

IN RE: CDC

Court house now empty except for Maintenance. DeGroot technology will be installing a telephone in the front entry of the annex that will allow Public to contact various offices in lieu of climbing to the upper level.

Clerk's Office has requested that we add an office machine to our Cardinal lease for copying books and documents in the Justice Center basement for the duration of the project (15-18 months). Commissioners agreed to pursue this.

Jon Frain and Stan Bennett recommended to serve on the Redevelopment Commission, ending December 31 2024. Jon owns Frain Mortuary and Stan is plant manager for Lightstream. Maurice Loehmer made a motion to approve both appointments as recommended, Michael McClure seconded and motion carried unanimously. All 7 Redevelopment Commissions seats are filled.
