Jeffrey Richwine made a motion to approve the appointment of Brian Ledley, Katie Bierrum and Isaiah Tidwell to the Redevelopment Commission as recommended, Sheila Hazemi-Jimenez seconded and motion carried unanimously. All terms will expire December 31, 2024.

Recommended to serve on the *TOURISM ADVISORY COUNCIL*: Vernon Gillum (Tippecanoe River State Park) and Christy Nicholson (Acorn Oaks Campground). Sheila Hazemi-Jimenez motioned to appoint Vernon Gillum and Christy Nicholson to the Tourism Advisory Council as recommended, Jerry Locke seconded and motion carried unanimously. Vernon Gillum's term will expire December 21, 2024 and Christy Nicholson's term will expire December 31, 2025.
